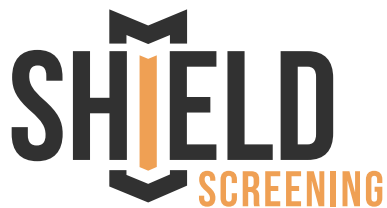
Verified identities help enhance candidate authenticity and accuracy.

Data is automatically captured from a candidate's ID, eliminating the time required to type personal information and any manual errors.

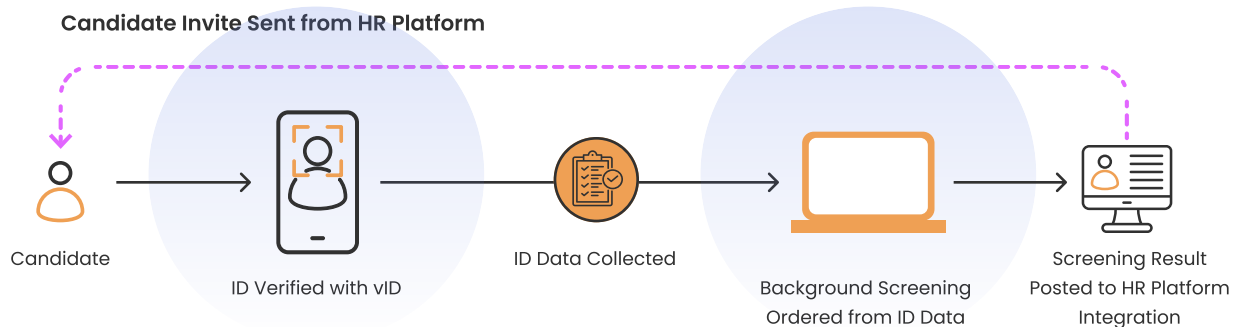
